PERMITS AND AUTHORIZATION CERTIFICATE

Application

The resolution requests, for which this Department is responsible, can be handed at the counter for receipt of submissions in the Services Center in the building of the Municipality of Bosanska Krupa, by filling out the appropriate forms available in the counter hall. The documentation which has to be submitted with the application, must be original or certified copy. The request shall include the prescribed fee, unless the applicant is exempted from paying taxes, for which the proof is required, or if for certain documents and actions tor which tax is not supposed to be paid. The certificate for permits and authorization is an administrative act and shall be adopted in accordance with the Law on Administrative Procedure ("Official Gazette of the Federation of BiH", 2/98, 48/99).

The application shall be accompanied by:

- The copy of the title deed or land registry entry,
- Deposit slip of payment for administrative fees ("The Decision on Municipal Administrative Fees .Off. Gazette of the municipality of Bos. Krupa" no. 1/14, 2/14, 6/14).

PERMITS AND AUTHORIZATION CERTIFICATE

In case that the required doklument does not exist, and considering that in the last war the most of the official records were destroyed, according to the ZUP regulations, the procedure for establishing whether the requested document was issued has to be conducted.
